

### Requirements you have to fulfill

- Individuals who are employees of Sri Lanka Thriposha Limited, or those directly or indirectly associated with the company as suppliers or agents, as well as their family members, are not eligible to apply for this.
  - (An affidavit certified by an attorney-at-law must be submitted in this regard.)
- A security deposit (Sash) of Rs. 1.5 million is required. (No interest or dividend will be paid on this deposit. Goods will be issued based on this deposit up to 90% of its value.)
- ❖ 03 years of experience related to the distribution of consumer goods and the handling of personnel required for the purpose. (Such as Driver and Sales Officer)
  - Applicants with experience in the distribution of consumer goods in these areas of operation will be given special consideration.
  - Distributors of competitive products (of the same kind) are not eligible to apply for this position.
- **❖** The applicant must be a permanent resident of the relevant administrative area. (*This must be certified by the Grama Niladhari*.)
- **\*** Vehicle fit for transportation of goods (suitably covered).
- **❖** Availability of storage facilities in an extent of 300 square feet suitable for storing goods within the respective area. (It should be a facility that has access way for 20 feet long lorries.)
